At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N. Zeeb Road in said Township, on the 12<sup>th</sup> day of October 2021, at 7:00 p.m.

The following preamble and resolution were offered by Courteau and supported by Jerome:

**WHEREAS**, The residents of the Wagner Ridge Court neighborhood have, through the approved process, gathered petition signatures in support of the creation of a special assessment district for the purpose of paving the unpaved portion of Wagner Ridge Court and submitted their petition to the Township of Scio, and

**WHEREAS**, This Board has designated the special assessment district against which the cost of engineering and determining the cost of the paving is to be assessed; and

**WHEREAS**, After due and legal notice, this Board has met and heard all persons interested with respect to the special assessment district;

**NOW THEREFORE BE IT RESOLVED**,

1. The Township Board finally determines that the special assessment district against which the cost shall be assessed shall consist of all land bearing the following parcel IDs:  
H -08-23-106-005, H -08-23-106-001, H -08-23-106-006, H -08-23-100-002, H -08-23-106-004,  
H -08-23-106-010, H -08-23-106-009, H -08-23-106-002, H -08-23-100-004, H -08-23-106-003,  
H -08-23-106-007, H -08-23-106-012, H -08-23-106-008, H -08-23-106-013, H -08-23-106-011,  
and directs the Supervisor to establish the assessment against such lands in the amount of

\$121,040 or \$8,069.33 per assessed parcel in a column provided therefor in the regular tax roll for the year 2022 which special assessment roll is hereby confirmed.

2. All other resolutions and parts of resolutions, insofar as they conflict with the provisions of this resolution, hereby are rescinded.




