At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N. Zeeb Road in said Township, on the 12<sup>th</sup> day of October 2021, at 7:00 p.m.

The following preamble and resolution were offered by Vogel and supported by Flintoft:

**WHEREAS**, The residents of the Merlin Way neighborhood have, through the approved process, gathered petition signatures in support of the creation of a special assessment district for the purpose of paving the unpaved portion of Merlin Way and submitted their petition to the Township of Scio, and

**WHEREAS**, This Board has designated the special assessment district against which the cost of engineering and determining the cost of the paving is to be assessed; and

**WHEREAS**, After due and legal notice, this Board has met and heard all persons interested with respect to the special assessment district;

**NOW THEREFORE BE IT RESOLVED,**

1. The Township Board finally determines that the special assessment district against which the cost shall be assessed shall consist of all land bearing the following parcel IDs:  
H-08-16-300-011, H-08-16-300-014, H-08-16-300-020, H-08-16-300-021, H-08-16-300-022,  
H-08-16-300-023, H-08-16-400-026, H-08-16-400-027, H-08-16-400-029, H-08-16-400-032 and directs the Supervisor to establish the assessment against such lands in the amount of in the estimated amount of \$233,044.00 or \$23,304.40 per assessed parcel in a column provided

therefor in the regular tax roll for the year 2022 which special assessment roll is hereby confirmed.

2. All other resolutions and parts of resolutions, insofar as they conflict with the provisions of this resolution, hereby are rescinded.


