Resolution to Establish Permanent Polling Places

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on February 22, 2022, at 7 pm.

Members Present: Hathaway, Palmer, Flintoft, Courteau, Jerome, Knol, Vogel

Members Absent: None

The following preamble and resolution were offered by Courteau and supported by Jerome.

WHEREAS, MCL 168.662(1) requires that the Scio Township Board of Trustees shall designate and provide suitable polling places for each precinct within the Township, and;

WHEREAS, MCL 168.662(1) requires that publicly owned or controlled buildings be used as polling places, unless it is not possible or convenient, and;

WHEREAS, the Clerk has determined it is not convenient to accommodate all voters in the available publicly owned or controlled buildings within Township boundaries, and;

WHEREAS, MCL 168.662(1) provides that the Scio Township Board of Trustees may use as a polling place a building owned or controlled by an organization that is exempt from federal income tax as provided by section 501(c) other than 501(c)(4), (5), or (6) of the Internal Revenue Code, and;

WHEREAS, MCL 168.662(3) provides that the Scio Township Board of Trustees may establish a polling place at a for-profit or nonprofit apartment building or complex in which 150 persons or more reside, and;

WHEREAS, all current and proposed polling places in the Township continue to provide the use of each space for a fee of One Dollar (\$1.00), and;

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the Township of Scio hereby designates the following permanent polling places for all elections held during 2022-23:

Precinct 1 Washtenaw Intermediate School District, 1819 South Wagner Road;
Precinct 2 Scio Township Hall, 827 North Zeeb Road;
Precinct 3 Washtenaw Intermediate School District, 1819 South Wagner Road;
Precinct 4 Kiwanis Club, 100 N Staebler Road, Suite C;
Precinct 5 Scio Farms Community Club House, 6655 Jackson Road;
Precinct 6 Washtenaw Intermediate School District, 1819 South Wagner Road;
Precinct 7 Polo Fields Main Club House, 5200 Polo Fields Drive;
Precinct 8 Scio Community Church, 1293 North Zeeb Road.

Be it further resolved that the Township Clerk shall take all necessary actions to implement this resolution, including providing notice to all voters.
