#### **AUTHORIZATION OF PLANNING INTERNS FOR 2022**

### May 10, 2022

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held on the 10th day of May 2022 at 7:00 p.m.

Members Present: Hathaway, Palmer, Courteau, Jerome, Knol, McLaughlin.

Members Absent: Flintoft.

The following preamble and resolution were offered by Trustee Courteau and supported by Trustee Knol.

WHEREAS, the FYE23 budget approved on March 29, 2022 included \$15,000 for the Planning Commission (Activity 701) for part-time employees (Account #707.000), and

WHEREAS the Planning Commission's Environmental Sustainability Task Force is being assisted by a Master's Project team from the University of Michigan's School of Environment and Sustainability, and

WHEREAS two members of the master's project team will be engaged in additional education and outreach activities during May through August 2022 to further the work of the Task Force; and

WHEREAS the work required for the education and outreach amounts to a summer internship of 15-16 hours per week for each of two interns for a total of four months; and

WHEREAS the work requirement and pay are in keeping with the Washtenaw County Living Wage of \$16.52, which would cover about 61 hours of work per month, a rate of \$1,000 per month per intern for a total of \$8,000 for the two interns;

NOW THEREFORE BE IT RESOLVED, that a total of \$8,000 from the approved FYE23 budget General Fund (101), Planning Activity (701, Account 707.000), be authorized to fund two sustainability interns.

NOW THEREFORE BE IT FURTHER RESOLVED, that the proposed FYE23 budget Authorized Positions be amended to increase the number of positions by 2.0 temporary position for period of 6 months.
