## TO UPDATE WATER AND SEWER CONNECTION CHARGE AND METHODOLOGY

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on October 11, 2022, at 7 pm.

The following preamble and resolution were offered by Clerk Flintoft supported by Trustee Brazeau.

WHEREAS, the Township of Scio maintains a water and sewer system fully paid for and financed by users of that system; and,

WHEREAS, the Township is able to connect new and existing buildings to the water supply and wastewater collection system; and,

WHEREAS, the Township Utilities Ordinance do direct that connection charges shall be based on one user equivalent multiplied by the appropriate factor; and

WHEREAS, the Township Utilities Ordinance does specify the American Water Works Association equivalent meter schedule to be used as a basis for charges utilizing equivalent factors;

NOW THEREFORE BE IT RESOLVED that the Scio Township Board of Trustees hereby adopts the following water and sewer connection fees, replacing those fees established by Resolution #2021-34, to be 100% of the computed values as follows:

Singler Equivalent User Charges	\$4,201	\$6,955

BE IT FURTHER RESOLVED that the Board directs the following methodology to be applied to the determination of Connection Fees:

- 1) The single user equivalent Debt Service charge will be updated annually each April 1 by the Finance and Utilities Directors for the upcoming fiscal year.
- 2) The single user equivalent charge will be determined for each the water and sewer system by dividing the equity position of the system(s) by the number of equivalent users connection to the system.
- 3) The calculation will use the system equity position and user equivalent counts as of the preceding March 31.

BE IT FURTHER RESOLVED that the Utilities Director is authorized to charge and collect such charges effective October 12, 2022.
