NOW, THEREFORE, BE IT RESOLVED THAT, the Scio Township Board of Trustees approves the attached proposed contract extension dated October 26, 2022 and hereby authorizes the Supervisor and Clerk to execute the contract and the accompanying grant applications for the years 2023-2026.

BE IT FURTHER RESOLVED THAT the transmittal of the executed documents condition the Township's acceptance of the contract are dependent on the award of the grant reimbursements as set forth in the October 26, 2022, letter, and the accompanying Grant Reimbursement Requests.
