**RESOLUTION TO REPEAL THE AUGUST 17, 2021, JOB DESCRIPTION OF THE SCIO
TOWNSHIP SUPERVISOR**

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on January 10, 2023, at 7 pm.

The following preamble and resolution were offered by Trustee Brazeau and supported by Trustee Knol.

WHEREAS, on August 17, 2021 the Scio Township Board approved a job description for the Township Supervisor; and

WHEREAS, Scio Township did not have a professional administrator or manager on August 17, 2021 ; and

WHEREAS, Scio Township hired Marc Thompson as a full-time interim administrator on December 27, 2022; and

WHEREAS, repealing the current Supervisor job description makes clear the delineation of job duties between the Township Supervisor and the Township Administrator/Manager; and

WHEREAS, the committee created by the Scio Township Board to study and recommend current Township duties and reporting practices has recommended repealing the August 17, 2021 job description of the Supervisor; and

WHEREAS, the interests of the Township of Scio are best served when a professional manager is responsible for running the day-to-day operations of the Township;

NOW, THEREFORE, BE IT RESOLVED THAT, the provisions of the August 17, 2021 Resolution 2021-31, adopting the Supervisor job description, are repealed in full; and

THEREFORE BE IT FURTHER RESOLVED THAT, the Supervisor shall only have those duties and obligations assigned to the office of Supervisor by state statute or otherwise delegated to the Supervisor by the Township Board.




