WHEREAS, the laws of the State of Michigan and the Scio Township Code of Ordinances grant the authority to collect fees to Scio Township and its departments; and

WHEREAS, the Scio Township Board of Trustees periodically evaluates the cost of services provided and approves a cost recovery fee schedule;

NOW THEREFORE BE IT RESOLVED that the Scio Township Board of Trustees hereby adopts the fee schedule, attached as an appendix to this resolution, pursuant to the Scio Township Code of Ordinances; and

BE IT FURTHER RESOLVED that the Utilities Department is authorized to charge and collect such fees effective immediately, and said fees are to remain in effect until such time as the Board of Trustees shall otherwise direct.
