NOW, THEREFORE, BE IT RESOLVED, that the Scio Township Board of Trustees has no objection to the closure of Huron River Drive for the 2022 Dexter-Ann Arbor Run from 8:00 a.m. to 11:00 a.m. on June 4, 2023.

BE IT FURTHER RESOLVED, that it is understood that the Ann Arbor Track Club will be responsible for any additional public safety costs during the event; and

BE IT FURTHER RESOLVED, that the Scio Township Clerk will send a copy of this Resolution to the Washtenaw County Road Commission and authorizes Doug Goodhue of the Ann Arbor Track Club to make this request from the Washtenaw County Road Commission.
