**RESOLUTION TO DECLINE RESPONSIBILITY FOR
THE HERITAGE VILLAGE COMMUNITY WASTEWATER
UTILITY SYSTEM**

At a Regular Meeting of the Scio Township Board of Trustees, Washtenaw County, Michigan, held at the Township Administration Building, 827 N. Zeeb Rd., in Scio Township, on May 9, 2023 at 7:00 p.m.

The following preamble and resolution were offered by Trustee Reiser and supported by Trustee Brazeau.

WHEREAS, Manchester Scio, LLC, a Michigan limited liability company has requested approval of a development ("Heritage Village") under the jurisdiction of Scio Township, a Michigan general law township; and

WHEREAS, Heritage Woods cannot be connected to the municipal wastewater system; and

WHEREAS, Heritage Woods has proposed a private community wastewater system; and

WHEREAS, Heritage Woods and Scio Township have negotiated a Development Agreement which includes terms for the Community Wastewater Utility System as required by Chapter 34 Article III Division 3 of the Scio Township Code of Ordinances; and

WHEREAS, the Michigan Department of Environment, Great Lakes, and Energy (EGLE) requires that Scio Township state whether it will accept or decline the community wastewater utility system prior to EGLE approving the system.

NOW THEREFORE BE IT RESOLVED that except as to the statements made in the Development Agreement for the Heritage Village Community Wastewater Utility System, Scio Township declines responsibility for the community wastewater utility system servicing the Heritage Village community.




