# RESOLUTION TO REFUND SURPLUS SPECIAL ASSESSMENT DISTRICT FUNDS FROM SCIO TOWNSHIP SPECIAL ASSESSMENT DISTRICT NO. 2013-5

At a meeting of the Board of Trustees of Scio Township, Washtenaw County, Michigan, held at the Township Hall, Township Hall, 827 North Zeeb Road, Ann Arbor, MI 48103, on the 25th day of July, 2023 at 7 pm.

The following resolution was offered by Trustee Reiser and supported by Trustee Knol.

WHEREAS, pursuant to MCL 41.721 the Township has the authority to determine that the whole or any part of the cost of a public improvement shall be defrayed by special assessments against the property especially benefited by the improvement; and

WHEREAS, the Township established the Scio Township Improvement District No. 2013-5 (the "District") and collected such a special assessment for road improvements within the District; and

WHEREAS, pursuant to MCL 41.732, the Township Board has determined that the total amount collected from the District was larger than necessary by more than 5% of the original roll and has determined that the surplus should be prorated among the properties assessed in accordance with the amount assessed against each parcel in the District; and

WHEREAS, the Township has determined that the amount of the surplus from the District to be refunded is in an amount equal to \$1,628,876.23, as of July 25, 2023;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of Scio as follows:

- 1. On December 1, 2023 and pursuant to MCL 41.732, the Township hereby orders a refund from the District in the amount of \$1,628,876.23, which amount shall be prorated among the properties assessed in accordance with the amount assessed against each property in the District.
- 2. Pursuant to MCL 41.732, the prorated amount refunded to each property within the District shall be applied toward the payment of the Township tax levied against such property in the District on December 1, 2023.

- 3. If there is no such tax levied against a property in the District, then the prorated amount shall be refunded to the respective record owner of such property on December 1, 2023.
- 4. Any resolution in conflict with this Resolution is repealed, but only to the extent to give this Resolution full force and effect.
