**RESOLUTION TO ESTABLISH SCIO TOWNSHIP MEETING HALL AS AN EARLY VOTING SITE  
FOR THE NOVEMBER 7, 2023 SPECIAL ELECTION**

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on August 15, 2023 at 7:00 pm.

The following preamble and resolution were offered by Trustee Reiser and supported by Trustee Knol.

WHEREAS, the Scio Township Clerk is responsible for administering early voting in this municipality, pursuant to MI Constitution Sec. 4 and Public Act 81 (2023); and,

WHEREAS, the Scio Township Hall is centrally located within the Township, and have been used for many years as a polling place on election days;

NOW, THEREFORE, BE IT RESOLVED THAT, Scio Township shall conduct early voting for the Special Election to be held on November 7, 2023; and

BE IT FURTHER RESOLVED THAT, the sole early voting site for Scio Township voters shall be the Scio Township Meeting Hall, located at 827 N Zeeb Road, Ann Arbor, MI 48103; and

BE IT FURTHER RESOLVED THAT, the hours of operation of the early voting site shall be 8 am to 4 pm daily, from Saturday, October 28 to Sunday, November 5, 2023, inclusive; and,

BE IT FINALLY RESOLVED THAT the Clerk is authorized to expend necessary funds budgeted in 101-262 (Elections) to properly notice the establishment of the Early Voting site.


