Resolution Authorizing Zeeb Road Pathway Connecting Communities Grant Application

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on Tuesday, August 29, 2023, at 7:00pm.

Members Present: Hathaway, Flintoft, Kerry, Knol, Reiser.

The following preamble and resolution were offered by Trustee Reiser and supported by Clerk Flintoft.

WHEREAS, Scio Township is constructing the Zeeb Road Pathway as an integral component of a network of non-motorized pedestrian pathways including a connection to the Border-to-Border Trail as it follows the Huron River; and

WHEREAS, once constructed, the Zeeb Road Pathway will connect Scio Township to multiple communities through which the Border-to-Border Trail passes and allow for people to connect more easily and safely with their neighbors throughout Washtenaw County without the necessity of an automobile; and

WHEREAS, the next phase of construction of the Zeeb Road Pathway will involve the design and construction of a pedestrian bridge across the Huron River as well as pathway segments on steep inclines of the north and south river banks; and

WHEREAS, the voters of Scio Township approved a Parks & Pathways millage with over 70 percent of the vote in August 2020 and the Township's goal is to use those millage dollars in combination with other funds to create non-motorized pathways such as the Zeeb Road Pathway, and

WHEREAS, Phase V of the Zeeb Road Pathway will require a combination of State, County and Township funds and Scio Township intends to invest a significant amount of Parks & Pathway millage dollars as part of that funding mix,

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Trustees authorizes the Director of Parks, Preserves, & Pathways to apply for a Washtenaw County Connecting Communities grant to help pay for the design and construction of Phase V of the Zeeb Road Pathway; and

BE IT FURTHER RESOLVED THAT Scio Township will potentially allocate at least \$600,000 of Parks & Pathway millage funds or other local funds on the design and construction of the Phase V of the Zeeb Road Pathway.
