RESOLUTION TO CONFIRM THE SPECIAL ASSESSMENT ROLLS APPROVED ON AUGUST 8, 2023

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on September 12, 2023, at 7:00 pm.

Members Present: Hathaway, Flintoft, Brazeau, Kerry, Knol, Reiser

Members Absent: Palmer

The following preamble and resolution were offered by Trustee Reiser and supported by Trustee Brazeau.

WHEREAS, the Township has determined that providing fire protection is in the best interest of the public health, safety, and welfare of the Township residents; and

WHEREAS, pursuant to the Township Police and Fire Protection Act, Act 33 of 1951, a township may provide that the cost of purchasing and housing equipment and general operations for fire protection may be defrayed by special assessment; and

WHEREAS, on May 9, 2023, the Township Board tentatively established the Special Assessment District and on June 13, 2023, held the required Public Hearing;

WHEREAS, on August 8, 2023, the Township Board provided a hearing for any objections to the Special Assessment District being created;

WHEREAS, on August 8, 2023, the Township Board set the Special Assessment District tax rolls.

NOW, THEREFORE BE IT RESOLVED THAT, pursuant to the Township Police and Fire Protection (Act 33 of 1951, as amended), this Board has established the boundaries of the special assessment district for fire protection to be all lands within the boundaries of the Township except for lands and premises exempt from the collection of taxes under the General Property Tax Act, P.A. 206 of 1893; and

BE IT FURTHER RESOLVED THAT, the amount of the special assessment levy for tax year 2023 shall be up to 1.35 mills; if voters approve only the Operating Question appearing on the November 7, 2023 ballot then the amount of the special assessment levy for tax year 2023 shall be up to 3.75 mills; or if voters approve both the Operating and Capital Questions appearing on the November 7, 2023, ballot then the amount of the special assessment levy for tax year 2023 shall be up to 4.50 mills; and,

BE IT FURTHER RESOLVED THAT the assessments levied for tax year 2023 shall be recognized as revenue in Fiscal Year 2024; and,

BE IT FURTHER RESOLVED THAT, all other resolutions, and parts of resolutions, insofar as they conflict with the provisions of this resolution, are rescinded; and,

AND BE IT FINALLY RESOLVED THAT, the Special Assessment District Tax Roll established on August 8, 2023, for Fire Protection, is confirmed.
