**Resolution for Poverty Exemption Guidelines**

At the Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, Held at the Scio Township Hall, 827 N. Zeeb Road, in said Township on January 9, 2024, at 7:00 p.m.

The following preamble and resolution were offered by Trustee Reiser and supported by Trustee Knol.

**Whereas**, the annual adoption of guidelines for poverty exemptions for property taxes is required of the Township Board of Trustees; and

**Whereas**, the principal residence of persons, who the Board of Review determines by reason of poverty to be unable to contribute to the public charge, is eligible for exemption in whole or in part from taxation under Public Act 390 of 1994 (MCL 211.7u); and

**Whereas**, the Township Assessor has drafted guidelines for the Board of Review to implement (2024 Policy Guidelines); and

**Whereas**, pursuant to PA390 of 1994, the Township of Scio, Washtenaw County adopts the 2024 Policy Guidelines drafted by the Assessor, which are incorporated here by reference.

**NOW, THEREFORE, BE IT RESOLVED THAT** the Assessor and Board of Review shall follow the guidelines drafted by the Assessor and adopted by the Scio Township Board of Trustees, and the federal guidelines in granting or denying an exemption, unless the Board of Review determines there are substantial and compelling reasons why there should be a deviation from the policy and federal guidelines and these reasons are communicated in writing to the claimant.
