Whereas, under Section 36-35 of the Scio Township Zoning Ordinance, "The township board shall establish a schedule of fees by resolution from time to time for administering this chapter. The schedule of fees shall be on public display in the office and may be changed only by the township board. No certificate or permit shall be issued unless required fees have been paid in full."; and

Whereas, the schedule of fees for development review by the planner has not been updated since 2015; and

Whereas, the schedule of fees should reflect the current economy and the time that it takes to do development review; and

Whereas, the Township Board desires to update the schedule of fees.

NOW, THEREFORE, BE IT RESOLVED THAT, that the schedule of fees under Section 36-35 of the Scio Township Zoning Ordinance is updated as shown on the attached Exhibit A,

AND BE IT ALSO RESOLVED THAT, the fee schedule is effective immediately upon the approval of this resolution.

Under Section 36-35 of the Scio Township Zoning Ordinance, Development review (site plans, subdivision plats, rezoning, etc.) is performed in accordance with a pre-agreed fee schedule. This schedule is established so that applicants, not the general fund, can be charged the appropriate review fees by means of a set fee schedule as developed by the Township. The fees outlined below are PLANNER REVIEW FEES only. There may be other fees associated with development review, such as Township administrative fees, Township Engineer review fees and Legal review fees that are not included in the below.
