WHEREAS, Scio Township has been operating without a township manager since September 15, 2024; and,

WHEREAS, the Scio Township Board of Trustees adopted Resolution 2024-21 on September 10, 2024, which assigned certain duties to officers and staff; and,

WHEREAS, the Scio Township Board of Trustees appointed an Ad Hoc Committee to work on filling the township manager position; and,

WHEREAS, at its October 16, 2024, meeting, the Ad Hoc Committee recommended the Office Coordinator supervise the Fire Chief, Project Manager and Parks Director; and,

WHEREAS, with the exception of any duties that are delegated by law to another township official, unless consent has been granted, the township board may revise this assignment of responsibilities at any time; and,

WHEREAS, the Board of Trustees anticipates that these assignments will be temporary until the Board recruits a candidate for township manager; and,

NOW, THEREFORE, BE IT RESOLVED, that effective October 22, 2024, the Office Coordinator will supervise the Fire Chief, Project Manager, and Parks Director.

BE IT FURHTER RESOLVED, that to assist with the transition, the Supervisor will submit a written report to the Board of Trustees with the status of projects and ongoing work involving the Fire Chief, Parks Director, and Project Manager.

BE IT FINALLY RESOLVED that any resolution in conflict with this resolution is repealed, but only to the extent to give this Resolution full force and effect.
