WHEREAS, Scio Township adopted its first Tree Fund Policy on October 8, 2024,

WHEREAS, the Tree Fund Policy requires a Tree Fund Plan that is updated annually, in concert with the Capital Improvement Plan; and,

WHEREAS, the Tree Fund Plan is projected for six (6) years, with annual evaluation and updates; and

WHEREAS, on December 17, 2024, the Parks Preserves and Pathways Director recommended a Tree Fund Plan to the Board of Trustees;

NOW THEREFORE BE IT RESOLVED, that the Scio Township Tree Fund Plan for 2026 -2031 as presented, is adopted; and,

BE IT FINALLY RESOLVED, that this Plan should be published and attested to according to law.


