CLERK'S COLUMN

he federal administration's assault on human rights, climate science, and democratic institutions is well organized and, so far, unrelenting. We must continue to hold our elected officials accountable, engage in peaceful protest, and forcefully reject these unjust federal policies at every turn we can. The federal administration is injecting these disastrous federal policies into our educational institutions, state governments, and local governments. I have my eyes wide open about the potential disastrous impacts on Township services and the well-being of our residents that we may see in the coming months and years. The Township Board is making contingency plans for some of the most immediate impacts but our work to improve Scio Township continues: we will continue to implement forward thinking programs based on well informed plans.

In the first months of 2025, the Board of Trustees adopted a comprehensive 6-year Capital Improvements Plan and a Township Budget

for Fiscal Year April 1, 2025 through March 31, 2026. The Capital Plan is comprehensive and the Budget is well considered. Find these documents on the Township website at sciotownship.org/finance. The Board of Trustees and Township staff worked together through a budget process that has become more inclusive and sophisticated over the last few years, this year's being the best process yet. Special thanks to Trustee Kathleen Brant who presented the budget to the Township Board and facilitated major decision points.

One set of decisions bears a deeper explanation. The Board of Trustees adopted a General Fund budget for 2025-26 that relies on the General Fund reserve—dipping into the reserves to meet the extraordinary need presented this year. Pursuant to the Township's *Order of Resource Use and Fund Balance Policy*, the Board of Trustees approved a budget that draws the unrestricted fund balance of the General Fund below the required policy minimum of 100% of the following year's operating expenditures.

Scio Township Clerk Jessica Flintoft swears in newly appointed Trustee David Read at the March 11, 2025 meeting of the Board of Trustees. Read ran for the office of Trustee in 2024 and came in fifth in a field that could only hold four nominees. He replaces Judy DeVooght Moenck, who resigned on February 28.

Scio's policy establishes a required minimum that is higher than that of most municipalities and allows the Township to draw below that minimum only for narrowly defined reasons. The Board of Trustees stated two such reasons for this authorization for the upcoming Fiscal Year: 1) planned legal defense expenses in State of Michigan v Kerry (Case #2024-24F3-0828-FY), the false criminal charges filed against the current Township Supervisor; and 2) planned use of reserves for part of the costs to replace the Township Hall's HVAC system. The other part of the costs to replace the HVAC may be funded through federal revenue from an IRS Elective Pay Program. But, to account for the possibility that the federal administration might stop payments that would otherwise be properly disbursed, the Board of Trustees voted to assign \$603,200 of General Fund fund balance to be disbursed in the event the revenue from the IRS is not received.

In these extraordinary times, please know that your local government, staff employees and elected officials alike, is committed to doing our best for the people of Scio Township. And that means, above all, serving all of our residents fairly and with kindness. Scio Township Hall continues to welcome all residents to pop in to ask a question, get a document notarized, or attend a public meeting. No matter your immigration status, national origin, ancestry, religion, race, color, age, sex, gender identity, sexual orientation, or disability: we are your public servants, and you are welcome here. MICHIGAN IS A NATIONAL LEADER IN SECURE AND ACCESSIBLE ELECTIONS

LETTER FROM THE FIRE CHIEF

ith the passage of the Fire Station 2 millage question last fall, we have been hard at work preparing for the start of the project. As this article is being written in early March, we are scheduling interviews with several Architects and Construction Managers. We are evaluating their past and current projects, their records of success, and their costs. The objective of this process is to give residents a quality product (a state-of-the-art fire station) at a fair price. The Requests for Proposals were distributed throughout the state and received a very good response. Update: The Board of Trustees approved an Architect and a

Construction Manager at the March 25 meeting and authorized the Supervisor and Clerk to sign the negotiated contracts.

Not long ago, the Township Board of Trustees authorized the Fire Department to purchase a smaller off-road vehicle for firefighting/EMS use within the community. We currently use a brush truck for outdoor fires that are inaccessible to conventional fire vehicles. Spring is the peak time for brush fires in the community, which often occur far from roads or driveways where our large engines can drive. Our brush truck is useful for some of these areas, but its size and weight prevent it from getting into many areas in the community. Our new vehicle,

which is equipped with a small fire pump and a 70-gallon water tank, can now get us to outdoor fires faster than we could before. The vehicle also has equipment to get sick or injured people from these inaccessible areas to an ambulance.

This will be a great asset for Scio parks, preserves, and pathways, which can be far from the road, as well as the larger private properties and farms in the community.

The Fire Department is grateful to the Board of Trustees for its continued support of our mission to protect and preserve life and property in Scio Township.

Not yet registered to vote in Scio Township?

You can register online at Michigan.gov/vote through Monday, April 21. From Tuesday, April 22 through Election Day, registration must occur in person at the Scio Township Clerk's office. Please bring proof of residency. The Scio Township Clerk's office is located in Scio Township Hall, 827 N. Zeeb Rd. Regular office hours are Monday-Friday, 8 am-4 pm. The Clerk offers additional weekend hours on Saturday, May 3 and Sunday, May 4 from 9 am-4 pm.

Scio Township typically has a history of high voter turnout, but the turnout for the last Special Election held for Dexter schools was only 19.2% in August of 2017. Scio voters in Precinct 2 need to show up to make decisions that directly impact their community. In the words of Sharon Salzberg, "Voting is the expression of our commitment to ourselves, one another, this country and this world."

JACKSON ROAD CORRIDOR STUDY

ackson Road is the commercial heart of Scio Township, but the corridor lacks a clear identity, safe walkways, and connected bike paths. Over the past ten years, new development has expanded into Scio Township that lacks character and is car-oriented. However, with recent additions such as breweries, coworking spaces, and mixed-use housing, the Township is on its way to establishing Jackson Road as a unique destination for residents and visitors alike.

The Township is developing a plan that will build upon previous planning efforts, identify opportunities to improve traffic safety, enhance walking and biking connections, and create a vision to guide future investments along Jackson Road.

The Township will be using public events, social media, and surveys to ensure you have a chance to make your voice heard about this project. The feedback you provide will help shape Jackson Road into a corridor that reflects

FROM THE UTILITIES DIRECTOR

THE CAPITAL IMPROVEMENT PLAN FOR UTILITIES

our elected Board of Trustees has carefully reviewed and vetted all recommendations for the Utility Department in the updated 2026-31 Capital Improvement Plan. Each project was evaluated for its importance and impact while considering the financial implications. Below are some of the planned capital improvements that have earned Board support. For a full list please visit the Township website for Plans under sciotownship.org/finance.

METRON METERS

Scio Township is entering the second year of mandatory water meter replacements with Metron meters. So far, nearly 1,000 new or replaced meters have been installed. This ongoing effort ensures accurate water-usage tracking and improved efficiency. Residents, please call the Scio Township Utilities Department at 734-369-9350 to schedule your water meter replacement.

SEWER CLEANING AND TELEVISING

Scio Township is beginning the second year of its sewer cleaning and televising program. Last year, work was completed in Walnut Ridge and most of the Uplands District. This year, the focus will be on the area in and around Polo Fields. Thank you for your cooperation as we continue this essential maintenance.

JACKSON ROAD PUMP STATION GENERATOR REPLACEMENT

Scio Township will be replacing the original Jackson Road Pump Station generator, which has been in service for over 30 years. This upgrade is essential to ensure reliable operation during power outages. Work is scheduled to begin this spring!

JACKSON ROAD PUMP STATION UPGRADES/ SEWER FORCE MAIN

Township consultants OHM-Advisors will be investigating the best options to upgrade Scio Township's main pump station to handle increased sewer flow. They will also explore options for pumping sewage to the City of Ann Arbor in case of a force main failure, as no redundancy currently exists in the system. The current timeline for these solutions to be implemented is approximately three years. This planning is essential for future reliability and capacity.

JACKSON ROAD METER PIT

OHM will begin designing engineering plans and technical specifications to replace Scio Township's 30+-year-old meter pit and main water feed valve. This proactive work ensures a smooth replacement next year, securing a reliable water supply for the future.

HOW'S YOUR SEPTIC?

The Michigan Department of Environment, Great Lakes, and Energy has teamed up with Michigan Saves, the nation's first non-profit green bank to offer **low-cost loans to homeowners who need to repair or replace their failing septic systems**. State-wide it is estimated that more than 20% of Michigan's 1.3 million septic systems are failing. Old septic systems beyond their life expectancy, outdated system designs and installations, improper use or overuse, and lack of maintenance can lead to untreated wastewater rising to surface water or into groundwater, potentially exposing people and animals to harmful bacteria and viruses. With the cost of a replacement septic system ranging from \$8,000 to \$30,000, low-interest loans to help finance these projects is a welcome benefit of Public Act 53 of 2022. The Septic Replacement Loan Program (SRLP) launched in the summer of 2023 and has resulted in thousands of gallons of sewage per day being safely and adequately treated so clean water can re-enter the environment. SPRING CLEAN-UP?

Sounds great! Don't let your spring clean-up contribute to water or ground pollution. Dispose of your home toxics through the County Home Toxics Collection Center located at 705 N. Zeeb Road (next to Township Hall). **Collection days are held most Saturdays April – November.** Check out their schedule, find out what materials they take, and register for an appointment at www.washtenaw.org/287, or call 734-222-3950. The Huron River Watershed Council has a great resource for safe disposal of common items containing toxic material, safe prescription medication disposal, and cleaning with natural materials (smells better, costs less, and is better for you and the environment!). SPRING UPDATE - ROADS ADVISORY COMMITTEE

he Roads Advisory Committee
researches and addresses a range
of issues related to the Township's
network of local roads; formulates
plans for road maintenance and improvements,
evaluates funding options, and collaborates
with the Township project manager, the
Washtenaw County Road Commission, and/
or outside contractors on projects. RAC does
take into consideration public input regarding
road issues. However, for maintenance issues
such as potholes, plowing, grading, etc., contact
Washtenaw County Road Commission at
wcroads.org.

Each year, the Roads Advisory Committee (RAC) works with the Washtenaw County Road Commission (WCRC) to establish which roads will be improved during the coming construction season. We are currently working on the 2025 road project list. RAC is also putting the final touches on a guide

for residents, "Special Assessment Nuts & Bolts for Public Roads." This guide will help residents initiate and successfully complete a Special Assessment District (SAD) to pay for paving their neighborhood gravel roads. This important document, along with the "Special Assessment Policy for Public Roads," also nearing completion, will provide processes that lead to improved local roads. When they are available, you will find those documents on the Township website at Sciotownship.org/RoadsAdvisoryCommittee.

RAC meetings are held on the first Wednesday of every month at 6:30 pm in the Township Hall. The public is encouraged to attend either in person or via Zoom. The link and the agenda materials are on the Township website, sciotownship.org.

Washtenaw County Road Commission has a very robust site for all information about our

PLANNING AND ZONING FOR YOUR DREAM PROJECT

re you a homeowner thinking about building a deck, an addition, or a shed? Are you thinking about opening a business in Scio Township or planning to expand your existing business? Scio Township works with the Washtenaw County Building Department, and all projects that require a building permit (decks, building additions, interior improvements, etc.) first need to obtain zoning compliance approval from the Township.

This spring the Planning and Zoning section of the Township website has been

updated to make complying with Township ordinances governing these activities easier than ever. Check out the landing page at sciotownship.org/planning to get started. This page will link you to every procedure, ordinance, policy, and application you need to get building in Scio. Click on one tab if you are a homeowner or a business owner, or a contractor working for either. Choose another tab if you are in the early planning stages and need to examine the Township Master Land Use Plan, zoning ordinance and the official Zoning Map, to find a likely location for your new home

meat, produce, and fruits? Well, good news!

You can help protect our community's
natural landscape and heritage
by volunteering for the Scio Land

Preservation Commission, which is now
celebrating its 20th year in our community.

The seven-member Land Preservation
Commission (LPC) meets once a month to
evaluate applications from landowners to
conserve their property in perpetuity through
land-conservation easements. A conservation
easement is a legally binding agreement
between a landowner and a government
agency or land trust to limit how the land may
be used. Conservation easements protect the
land's conservation values, such as scenic
views, water quality, and natural habitats.

The LPC also oversees an innovative Buy, Protect, Sell program, through which our Township buys properties deemed highly important to conserve, protects them through a land-conservation easement, and then re-sells them at a discounted price to a taxpaying landowner who agrees to use the land according to the conservation agreement.

Over the past 20 years — using dedicated funding from a voter-supported millage — the LPC has completed 37 land conservation projects. The total land area protected is 1,709 acres, with 45 percent of that land in natural features (woods, streams, and wetlands). Seventeen of these properties are publicly accessible as parks, preserves, or pathways.

POPKIN CEMETERY

re you aware that a historic cemetery exists in Scio Township? There are actually a few! Popkin Cemetery is located at 4230 Pratt Rd. and dates back to 1832. Many of you may know it: area walkers and runners sometimes use it as a meditative place to rest.

On February 11, 2025, the Scio Township Board of Trustees adopted a resolution to perpetually care for Popkin Cemetery. **Scio Township has developed a small budget to take on caring for Popkin and possibly other sacred burial grounds.** The Scio Township Parks Department is enthusiastically on board to assist in the yearly maintenance of Popkin.

In October of 2024 nearly 50 volunteers, including members of the Daughters of the American Revolution (DAR) and Sons of the American Revolution (SAR), gathered for an initial clean-up of Popkin Cemetery. A local Boy Scout, Jayden Song, worked on Popkin Cemetery as part of his Eagle Scout Badge and

Future plans for Popkin include installation of a new sign to designate it as an historic cemetery, replacement of the wire fencing with a durable and low-maintenance fence, and contracting with a Sexton to help guide the Township with ongoing care of the cemetery, including repair of the many broken grave markers.



SCIO PARKS, PRESERVES AND PATHWAYS

he Scio Township Board of Trustees recently adopted its first Tree Fund Policy. The Tree Fund is the result of negotiations between the Township Board and developers whose plans entail removing landmark trees. These funds are then used to mitigate tree loss throughout the Township. The Tree Fund Plan is projected for six years, with annual evaluation and updates, in concert with the Capital Improvements Plan (CIP), and the annual appropriation to be included in the Township's budget. These funds shall be used in Scio Parks and Preserves for foresting consultation, site preparation, pine removal and selling, tree purchase and planting, tree cages, and ongoing maintenance.

On March 11, our Parks Director oversaw a 6.5acre prairie burn on the **Van Curler Preserve**, located between Huron River Drive and Joy



Road north of Dexter-Huron Metro Park. The controlled burn removed various non-native plant species in the prairie

area. Next steps for remediation of this preserve include spreading native seed mixes and installing bird nesting boxes. Use the QR code to access drone aerial footage of the burn.

Thank you to those who attended and volunteered their time at the **February Volunteer Mixer event held at Township Hall.** This event was held to introduce prospective volunteers to the parks and preserves. On behalf of the Parks Department,

we look forward to working with you! On the March 15 volunteer day held at **Liberty Pond Nature Area**, located east of S. Parker off West Liberty, six bluebird nest boxes were installed. Each nest box was cleared of invasive species to promote the use of the boxes by bluebirds. Special thanks to those who volunteered.

Seasonal staff will soon begin the work of maintaining and upgrading the park experience for residents and visitors. They also plan to coordinate Workdays on Saturdays from May through September. Future volunteer opportunities for vernal pool-, butterfly-, and nest box-monitoring are forthcoming.



GET THE JUMP ON INVASIVES

In 2024, lesser celandine (Ficaria verna), a spring ephemeral plant found in forest floodplains, was added to Michigan's watch list. This plant spreads rapidly, appears very early in spring and hides underground well before summer's heat begins, making it extremely difficult to eliminate once established. Consider downloading the MISIN: Report Invasive Species smartphone app to learn about and help capture your field observations on local invasive plants and animals. You can also subscribe to michigan.gov/egle/outreach to find out about environmental classes and webinars, brochures and conferences from the Michigan Department of Environment, Great Lakes, and Energy.
