WHEREAS, the Board of Trustees has, during the year, reviewed and approved expenditures against the Scio Township budget appropriations; and

WHEREAS, pursuant to the Uniform Budgeting and Accounting Act of 1968, as amended, the legislative body shall adopt a balanced budget including all supplemental appropriation approvals; and

WHEREAS, the Board of Trustees has the sole authority to adopt and amend the budget.

NOW, THEREFORE, BE IT RESOLVED THAT, the general appropriations of the Scio Township for the fiscal year beginning April 1, 2025 and ending March 31, 2026, complies with the balanced budget requirements and the following fund appropriations are therefore amended and approved as reflected in Attachment A, adopting Fund 494 at the fund level of \$1,360,000.





Fire Truck

\$ 250,000.00

The DDA Chair requested this line item to support transit in the DDA district.

Fire Fund - Fire Inspections

\$ 100,000.00

This was added at the request of the DDA to defray the cost of backflow prevention inspections in the DDA district.
