TRANSIENT MERCHANT APPLICATION AND LICENSE FEES

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on July 22, 2025 at 7:00pm.

The following preamble and resolution were offered by Yaple and supported by Reiser.

WHEREAS, the Transient Merchant Ordinance No. 2025-03 was adopted by the Board of Trustees on May 27, 2025; and,

WHEREAS, The ordinance includes a section on Transient Vendors, otherwise known as food trucks; and,

WHEREAS, Transient Merchants, including Transient Vendors, are required to obtain a license when doing business within the Township; and,

WHEREAS, an applicant for a license under this article must file a sworn application with the Township clerk, on a form to be furnished by the Township clerk, EXHIBIT A; and,

WHEREAS, the Ordinance contemplates that the Township Board will adopt a resolution establishing an application fee, to be paid at the time of submitting the application; and,

WHEREAS, Transient Merchants not exempt under Section 12-21 of the Ordinance are also subject to a license fee established by a resolution of the Township Board; and,

WHEREAS, all applicants for a license under the Ordinance are also subject to a background check, which if performed by the Township will incur a cost to be paid by the applicant;

NOW, THEREFORE BE IT RESOLVED THAT the Transient Merchant application fee is \$50.00, to be paid at the time an application is submitted; and,

BE IT FINALLY RESOLVED THAT the Transient Merchant license fee is \$25.00 per month for every month the transient merchant intends to operate in the Township, as stated in the application, and is payable at the time the license is granted.


