# January 26, 2021

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N. Zeeb Road in said Township, on the 26<sup>th</sup> day of January 2021, at 7:00 p.m.

Members Present: Hathaway, Flintoft, Courteau, Jerome, Knol, Vogel. Members Absent: Palmer.

The following preamble and resolution were offered by <u>Terome</u> and supported by <u>Knol</u>.

WHEREAS, The residents of the Westview Way and Southwood Court neighborhood have, through the approved process, gathered petition signatures in support of the creation of a special assessment district for the purpose of paving the unpaved portion of Westview Way and Southwood Court and submitted their petition to the Township of Scio, and

WHEREAS, This Board has designated the special assessment district against which the cost of engineering and determining the cost of the paving is to be assessed; and

WHEREAS, After due and legal notice, this Board has met and heard all persons interested with respect to the special assessment district;

### NOW THEREFORE BE IT RESOLVED,

- Pursuant to Act 188, Public Acts of Michigan of 1954, as amended, this Board establishes a new special assessment district to prepare engineering and cost estimates so that the public street of Westview Way and Southwood Court may be paved with asphalt; and
- 2. The Township Board finally determines that the special assessment district against which the costs shall be assessed shall consist of all land bearing the following parcel IDs:

H-08-35-115-001, H-08-35-115-002, H-08-35-115-003, H-08-35-115-004, H-08-35-115-005, H-08-35-115-006, H-08-35-115-007, H-08-35-115-008, H-08-35-115-009, H-08-35-115-010, H-08-35-115-011, H-08-35-115-012, H-08-35-115-013, H-08-35-115-014, H-08-35-115-015, H-08-35-115-016, H-08-35-115-019.

- 3. All other resolutions and parts of resolutions, insofar as they conflict with the provisions of this resolution, hereby are rescinded.
- 4. Furthermore, the Township Board gives notice that it will meet on Tuesday, February 23 to hold a public hearing to approve the Special Assessment District roll for engineering and directs the clerk to publish and mail the notice of hearing as required by law.
