RESOLUTION NO. 3

February 23, 2021

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N. Zeeb Road in said Township, on the 23rd day of February 2021, at 7:00 p.m.

Members Present: *Hathaway, Flintoft, Courteau, Jerome, Khol, Vogel.*

Members Absent: *Palmer.*

The following preamble and resolution were offered by *Jerome* and supported by *Vogel*.

WHEREAS, pursuant to Act 188, Public Acts of Michigan of 1954, as amended, the Township Board has declared its intention to create a special assessment district for the purpose of conducting engineering and cost estimates preliminary to paving the unpaved portion of Merlin Way; and

WHEREAS, This Board has designated the special assessment district against which the cost of \$12,300 engineering and determining the cost of the paving is to be assessed; and

WHEREAS, After due and legal notice, this Board has met and heard all persons interested with respect to the special assessment district and the assessment;

NOW THEREFORE BE IT RESOLVED,

1. The Township Board finally determines that the special assessment district against which the cost shall be assessed shall consist of all land bearing the following parcel IDs:

H-08-16-300-011, H-08-16-300-014, H-08-16-300-020, H-08-16-300-021, H-08-16-300-022,
H-08-16-300-023, H-08-16-400-026, H-08-16-400-027, H-08-16-400-029, H-08-16-400-032,

and directs the Supervisor to establish the assessment against such lands in the amount of \$1,230

in a column provided in the regular tax roll for the year 2021 which special assessment roll is hereby confirmed.

2. All other resolutions and parts of resolutions, insofar as they conflict with the provisions of this resolution, hereby are rescinded.




