RESOLUTION APPROVING FY20-21 BUDGET AMENDMENTS

March 23, 2021

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held via Zoom, on the 23rd day of March 2021 at 7:00 p.m.

The following preamble and resolution were offered by Jerome and supported by Courteau.

WHEREAS, the Board of Trustees has, during the year, reviewed and approved expenditures against the Scio Township budget appropriations; and

WHEREAS, pursuant to the Uniform Budgeting and Accounting Act of 1968, as amended, the legislative body shall adopt a balanced budget including all supplemental appropriation approvals; and

WHEREAS, pursuant to the Uniform Budgeting and Accounting Act of 1968, as amended, a balanced budget is defined as estimated total expenditures including an accrued deficit shall not exceed estimated total revenues including a surplus; and

WHEREAS, the Board of Trustees has the sole authority to adopt and amend the budget.

NOW, THEREFORE BE IT RESOLVED, that the general appropriations of the Scio Township for the fiscal year beginning April 1, 2020 and ending March 31, 2021, complies with the balanced budget requirements and the following fund appropriations are therefore amended and approved as attached hereto:




